




Supplementary figure 1. DSM-XC item response distribution for the whole sample.





Supplementary figure 2. Sensitivity across DSM-XC domains for psychiatric diagnoses using intensity and frequency framings.





Supplementary figure 3. Specificity across DSM-XC domains for psychiatric diagnoses using intensity and frequency framings.








